C. Collection of personal information

The following types of personal information may be collected, stored, and used:

1. Information about your computer, including your IP address, your geographical location, browser type and version, and operating system;
2. Information about your visits and use of the site, including the source of the referral, the length of the visit, page views, and your transit routes on the site.
3. Information, such as your e-mail address, that you enter when registering on our site;
4. Information, such as your name and e-mail address, that you enter to subscribe to our e-mails and / or newsletter.
5. The information you enter while using the services on our site.
6. Information generated while using our site, including when, how much, and under what circumstances you use it.
7. Information that you publish on our site with the intention of publishing it on the Internet, which includes your username, profile photos, and the content of your comments.
8. Information included in the messages you send us by e-mail or through our website, including the content of the message and its metadata.
9. Any other type of personal information you send to us.

Before disclosing to us the personal details of another person, you must seek the consent of that person both for the sharing and for the processing of those personal details under this policy

D. Use of your personal information

Personal information provided to us through our site will be used for the purposes stated in this policy, or on the relevant pages on the site. We may use your personal information for the following purposes:

1. Managing our site and business.
2. Customize the site for you.
3. Send you non-marketing commercial messages.
4. Send you email alerts that you have specifically requested.

5. Sending our newsletter to you by e-mail, if you requested it (you can let us know at any time if you no longer need us to send newsletter)
6. Sending marketing messages related to our business and the businesses carefully selected third party companies that we believe you may be interested in, by mail or, in cases where you specifically agree, by e-mail, or through similar technologies (you can let us know at any time if you are no longer interested In marketing messages);
7. Providing statistical information regarding our users to a third party (but this third party will not be able to identify any single user according to the information)
8. Handling inquiries and complaints submitted by you or relating to you and related to our site.
9. Keep our site secure and prevent fraud.
10. Verification of compliance with the terms of service that dictate the use of the site (including monitoring of private messages sent through the private messaging service of our site)
11. and other uses.

E. Repairs

F. cookies

Our site uses cookies. A cookie is a file that contains an ID (string of letters and numbers) sent by a web server to a web browser and stored in a browser. Then, the ID is sent back to the server whenever the browser asks the server to display a web page. Cookies can be either "stubborn" cookies or "session" cookies: a stubborn cookie will be stored in your browser and will remain valid until the expiration date set for it, unless it is deleted by the user before the expiration date; An action cookie, on the other hand, will expire at the end of your current browsing time, when you close your browser. Cookies usually do not include information that personally identifies users, but personal information we store that pertains to you may be linked to information stored and received from cookies.

In Firefox (version 24) you can block all cookies by clicking on "Tools," "Options," "Privacy," and selecting "Use custom settings for history" from the drop-down menu, then uncheck "Get cookies from sites" ;

And in Chrome (version 29), you can block all cookies by going to the "Customize and Control" menu, then click on "Settings," "Show advanced settings," and "Content settings," then select "Block sites from setting" Data "under the heading" Cookies. "

Blocking all cookies will have a negative impact on the ease of use of many sites. If you block cookies, you will not be able to use all the options on our site.

- ✓ You can delete cookies that are already stored on your computer — for example:
- ✓ In Internet Explorer (version 10), you need to delete cookies manually (you can find instructions for this at <http://support.microsoft.com/kb/278835>);

In Firefox (version 24), you can delete cookies by clicking "Tools," "Options," and "Privacy," then selecting "Use custom settings for history," and clicking "View cookies," then "Remove" All the cookies "

- ✓ In Chrome (version 29), you can delete all cookies by going to the menu "Customize and control," then click on "Settings," "Show advanced settings," and "Clear browsing data," then select "Delete cookies and other site and plugin data," and finally click "Clear browsing data. "
